FOREWORD

We are pleased to present the Annual Report on Port State Control in the Mediterranean region for year 2016 which is published under the auspices of the Port State Control Committee of the Mediterranean MoU.

The 10 members of the memorandum have carried out 5,312 inspections compared with 5,740 in 2015. The number of detentions was 300 in 2015 and slightly decreased to be 228 detentions in 2016.

There are several notable developments in the Med MOU in 2016. The Med MoU held the annual 18^{th} Port State Control Committee Meeting in Aqaba, Jordan in October 2016. From 1^{st} September 2016 to 30^{th} November 2016, the MED MOU carried out a Concentrated Inspection Campaign (CIC) on Cargo Securing. A data exchange agreement between Med MoU and Genescape Vesseltracker was agreed. By the end of 2016, the Secretariat has been certified with ISO 9001:2015.

With the 20th anniversary of the Mediterranean Memorandum of Understanding on Port State Control that coming up in 2017, the commitment of members, to cooperate against substandard ships still remains a critical success factor for the future.

We would like to thank all the members of the Management Advisory Board (MAB) who continued to serve the Med MoU throughout 2016 and all of the Committee Member States for their support during the year and we would like especially to thank all of the Med MoU Port State Control Officers and their Administrations for their excellent work throughout the year.

OVERVIEW

Introduction:

This Annual Report is published under the auspices of the Med MoU committee on PSC. This annual report is the eleventh issue and covers port State control activities and developments in the year 2016.

In accordance with the provisions of the Memorandum, the Authorities which have signed and formally accepted the Memorandum or which have been accepted with unanimous consent of the port State control committee would become full members.

Currently; the Memorandum has 10 full members namely: Algeria, Cyprus, Egypt, Israel, Jordan, Lebanon, Malta, Morocco, Tunisia and Turkey.

The Port State Control Committee established for Monitoring and controls the implementation and on-going operation of the Memorandum.

The Committee consists of representatives of the member Authorities and also observers from the maritime Authorities and the inter-governmental organizations which have been granted observer status by the committee, namely: International Maritime Organization (IMO), International Labour Organization (ILO), European Commission (EC), Paris MoU, Black Sea MoU and the US Coast Guard. The Secretariat of the Memorandum is located in Alexandria, Egypt and its Information Centre in Casablanca, Morocco.

For the purpose of the Memorandum, the following instruments are the basis for Port State Control activities in the region:

THE COMMITTEE

The Eighteenth Committee Meeting was held in Aqaba, Jordan from 25 to 27 October 2016. The meeting was attended by the representatives of the member Authorities of Cyprus, Egypt, Jordan, Malta, Morocco, Tunisia and Turkey, observers from Paris MoU, Black Sea MoU and European Maritime Safety Agency (EMSA) participated by invitation extended from the Committee.



The Med MoU 18th Committee meeting 25th – 27th October 2016 (Aqaba, Jordan)

Important outcomes of this meeting:

- The Committee noted that "Ballast Water Management Convention" will be come into force by September 2017, and requested MAB to work on drafting guidelines for the "Ballast Water Management Convention"
- The Committee meeting discussed Data Exchange Agreement with Lloyd's List Intelligence and approved the renewal of the Data Exchange Agreement with Lloyd's List Intelligence for a period of three years.
- The Committee meeting reviewed the proposed agreement with Genscape Vesseltracker and agreed with MAB recommendation to sign the Agreement with Genscape Vesseltracker for the period of one year.
- The Committee meeting encouraged all member states to nominate Maritime Ambassadors to the IMO.
- The Committee meeting requested CIMED to add a checkbox for ISM related deficiencies in the inspection form.
- The Committee meeting requested CIMED, to prepare and present, to the MAB, a technical and financial proposal for developing a business intelligent tool with the scope of highlighting trends of information within the Med SIS system.



• MANAGEMENT ADVISORY BOARD MEETINGS (MAB)

The Management Advisory Board for the Mediterranean Memorandum of Understanding on Port State Control met two times in year 2016. It was composed of participants from Cyprus, Jordan, Morocco, Turkey, Chairman, the Med MoU Secretariat, and CIMED.

- The Sixteenth meeting took place in Marsa Malta from $2^{nd} 3^{rd}$ August 2016.
- The Seventeenth meeting took place in Aqaba Jordan on 24th of October 2016.

MAB recommendations:

Through two meetings following are the outline remarks on the recommendations presented to the 18th Committee Meeting:

- The MAB meeting recommend to the committee to celebrate the 20th anniversary of the Med MoU during the 19th Committee meeting by inviting honored persons "who was from the Med MoU founders, persons who served the Med MoU and efforts was reflected and contributed to the progress and improvement of the Med MoU".
- The MAB meeting recommend to the Committee to consider the issue of PSCOs exchange program as an activity under the umbrella of training and education.
- The MAB meeting after reviewing the questionnaire and guidelines of the CIC on "Cargo Securing" has decided to follow Tokyo MoU CIC on "Cargo Securing" from 1st of September to the 30th of November 2016.

THE INFORMATION CENTER (CIMED)

The Med MoU Information Center has been established in Morocco, for the purpose of exchanging information on port State inspection, in order to make available to authorities information on inspection of ships on other regional ports to assist them in their selection of foreign flag ships to be inspected and in the exercise of port State control in the region.

Most important achievements of the CIMED:

- 1. The exchange data is always current with (EQUASIS, LLI, IMO, HIS, BS MoU).
- **2.** From July 2015, the Electronic Platform (MaKCs) hosting DLP and on Rule Check tool is available for all Med MoU PSCO's.
- **3.** MEDSIS mobile / Tablet is a public app displaying data from MEDMOU on port state control system, android version is available on Google store, and IOS version is also published.

APPEAL ON DETENTIONS

During 2016 the Med MoU Secretariat received one appeal against detention in the Mediterranean region, the M/V "VOLGO-BALT 179" The Med MoU Secretariat setup a review panels according the Memorandum for the cases. As the majority of the panel members did not support the decision of detention, the detention was removed from the system.

CONCENTRATED INSPECTION CAMPAIGN (CIC)

Between the 1st of September 2016 and the 30th of November 2016, Med MoU member states carried out a Concentrated Inspection Campaign (CIC) on Cargo Securing.

The objective of this CIC is to:

- Measure compliance with the requirements of the applicable international conventions;
- Ensure that the Master, Officers, and Crew are familiar with procedures for cargo stowing arrangements; and,
- Raise awareness of the hazards associated with cargo stowage and with safe practices for cargo stowage;



1,077 ships were inspected during the period of CIC and 663 inspections were performed with a CIC questionnaire.

33 ships were detained in the CIC. One detention or 3% of the detentions were CIC topic related. The overall detention rate (Percentage of all detentions per all inspections using CIC questionnaire) was 2.4%. The CIC topic related detention rate was 0.15%.

CO-OPERATION WITH INTERNATIONAL ORGANIZATIONS

> International Maritime Organization (IMO)

- The Med MoU has inter-governmental status (IGO) since 2006 in IMO meetings.
- Exchange of Data with IMO; the uploading into GISIS is always current starting from August 2011.

European Commission (EC)

SAFEMEDIII project; implemented by European Maritime Safety Agency (EMSA). Most important achievements of the project are following:

- Revision of the MEDMOU procedures for PSC adopted by the MEDMOU Committee
- Newly adopted MEDMOU procedures added to RuleCheck and made available to MEDMOU PSCOs
- Creation of a DLP module on MEDMOU procedures

CO-OPERATION WITH PARIS MOU

The Med MoU has established and maintained effective and close cooperation with the Paris MoU, both at administrative and technical levels.

Chairman of Med MoU on PSC **Capt. Mark A. Chapelle** represented the Med MoU at the 49th Paris MoU Committee meeting in Haugesund, Norway, on 23-27 May 2016.

Paris MoU organized the Specialized Training on the Inspection of Passenger in Trieste, Italy from 10 to 13 May 2016. The Maritime Authority of Turkey and the Maritime Authority of Tunisia representatives participated in the course on behalf of the Med MoU. Paris PSC organized the 61th Seminar in St Malo, France from 21 to 23 June 2016. The Maritime Authority of Turkey representative participated in the course on behalf of the Med MoU.

CO-OPERATION WITH BLACK SEA MOU

The Med MoU has a special cooperation with the Black Sea MoU in the area of exchanging PSCOs to gain experience and harmonization on the job training between both MoUs.

The Med MOU was represented by the Republic of Turkey at the 17th Black Sea MoU Committee meeting in 2016 in Sochi Russian Federation from 12 to 14 April.

CO-OPERATION WITH TOKYO MOU

The Sixth general training course (GTC6) for PSCOs organized by the Tokyo MoU, in cooperation with IMO was held in Japan, from 22 August to 16 September 2016; the Maritime Authority of Jordan representative participated in the course on behalf of the Med MoU.

CO-OPERATION WITH INDIAN OCEAN MOU

The Expert Mission Training on Port State Control (PSC), organized by the Indian Ocean MoU, in cooperation with IMO was held in Bandar Abbas, the Islamic Republic of Iran, from 5 to 16 November 2016. The Maritime Authority of Jordan representative participated in the course on behalf of the Med MoU.



ANNUAL STATISTICAL REPORT 2016

In the following annual statistics the facts and figures of 2016 are listed, the figures show a decrease in the number of inspections and detentions.

INSPECTIONS

With a total number of 5,312 inspections performed in 2016 the inspection figures showed a decrease of 428 inspections (7.4%) compared with the figures of 2015.

The greatest contribution for inspections was from Turkey with 1,527 inspections then from Egypt with 1,060 inspections.

The greatest percentage of inspections was in the "General cargo/multipurpose ship" which was 1,969 inspections (37% of all inspections).

DETENTIONS

The detention figures showed a slight decrease in the number of detentions in 2016 compared with 2015. The average detention rate in 2016 is 4.30% which is lower than 2010 which showed a detention rate of 7.77%.

The greatest percentage of detentions was on "General cargo/multipurpose ship" which is 168 detentions (73% of total number of detentions).

DEFICIENCIES

Number of deficiencies (13,585)

In 2015 the number of deficiencies recorded was 15,823 deficiencies; in 2016 this number decreased by (14%) compared with 2015. The ratio of deficiencies per inspections decreased from 2.76 in 2015 to 2.55 in 2016.

The greatest percentage of deficiencies recorded was on "Safety of navigation" with 18% of total number of deficiencies (2,524 deficiencies), 982 deficiencies recorded for the "Nautical publications" and 347 deficiencies for the "Charts".

Number of ships with deficiencies (2,741)

In General cargo/multipurpose ship" the greatest number of deficiencies were recorded which were 1,335 deficiencies (49% of total number of deficiencies).







Number of inspections








Number of detentions

Detentions in % of inspections








Inspection : 5312 - Detention : 228 - Inspections with deficiencies : 2741











Number of Inspections, Detentions and Inspections with deficiencies per member state






Number and % of inspection, deficiencies and detention per ship's type




Number and % of nature of deficiencies
